We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.




4. Opinion

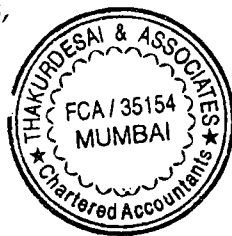
On the basis of our examination we report that :



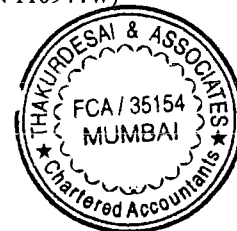

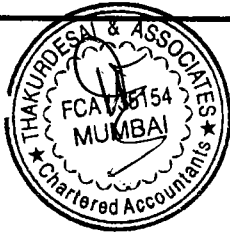
