- ii. In the case of the Income & Expenditure Account of the surplus for the year ended on that date.

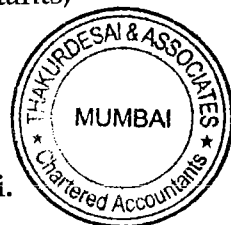

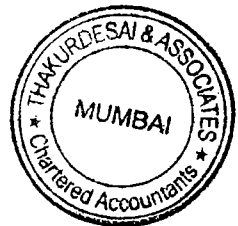

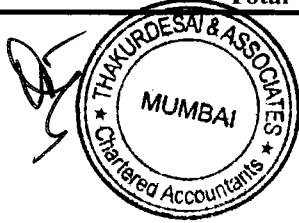
