



Subject: Report of the Adhoc Nominations Committee (ANC) for conduct of CSI National Elections for the Year 2018-2019/2020.

Dear CSI Members,

Greetings of the day!!!!

This is to inform you that on the basis of the resolution passed in Special General Body Meeting (SGM) of CSI held on 20th May, 2018 at New Delhi, constituting an Adhoc Nominations Committee (ANC) to conduct the CSI National Elections as per the CSI Constitution 2013, as the duly elected NC could not conduct the elections 2018-2019/2020 and their term expired on 31-03-2018, which cannot be extended, anymore, constitutionally. In light of the same, the Notification for conduct of elections was issued by the ANC on 29th May, 2018 itself. The required notice for Call for Nominations was also uploaded on the CSI Web-portal. However, without any information to the ANC, it was first deactivated and then removed from the web-portal, and was not re-uploaded on the web-portal, despite the repeated reminders to the ExecCom. On the other hand, on behalf of the ExecCom, Mr. Gautam Mahapatra, the then Vice President, kept repeatedly influencing the ANC to give only 15 days time for voting period (which according to the CSI Byelaws 5.5, should be minimum 30 days; **Quote "In no case shall the time given to the Voting Members to cast their votes, shall be less than 30 days" Unquote**) for the voting and conduct elections on truncated database of around 5000 members (as was done in the year 2017-2018/2019 elections), instead of conducting the election on the complete database of around 17000 bonafide CSI members. ANC strongly objected the same and refused to violate the Constitution, in any manner, for conduct of the elections. Finally, when Mr. Gautam Mahapatra, failed to influence the ANC, he wrote, vide his email dated 11th June, 2018, to the ANC that the election has been put on hold. Then after, Emergency General Body Meeting (EGM) held on June 30, 2018 at New Delhi, once again endorsed the Constitution of the same ANC for conduct of the CSI National Elections 2018-2019/2020 and directed the ANC to complete the elections, as per the CSI Constitution 2013, within next two months. Please refer to <http://csi-elections.org/> for minutes of the EGM. In light of which, ANC re-started the required process for conduct of CSI National Elections 2018-2019/2020.

Based upon the last experience of non-cooperation and continuous interference from CSI ExecCom for conduct of elections using <http://csi-india.org/> web-portal, ANC decided to conduct the CSI National Elections 2018-2019/2020, through a dedicated web-portal <http://csi-elections.org/>, to avoid any possible interference from the ExecCom / CSI HQR, etc., as mandated by the General Body, and initiated the Election process with immediate effect. As per the announced election schedule, the ANC, after consideration of all the withdrawals, scrutinized all the nominations. The summary of the Nominations is as under:-
